MODELS OF TRADE AND FACTOR FLOWS BASED ON DIFFERENCES IN FACTOR ENDOWMENTS GIVE CLEAR PREDICTIONS AS TO HOW GLOBALIZATION AFFECTS INEQUALITY AND DEVELOPMENT MODELS IN WHICH PRODUCTIVITY DIFFERENCES BETWEEN COUNTRIES DRIVE TRADE AND FACTOR FLOWS GAVE MORE AMBIGUOUS PREDICTIONS UNFORTUNATELY PRODUCTIVITY DIFFERENCES SEEM NECESSARY TO UNDERSTAND MANY THOUGH NOT ALL BIG PICTURE GLOBALIZATION INEQUALITY AND DEVELOPMENT OUTCOMES THE FACTOR ENDOWMENT PREDICTIONS HELP GIVE INSIGHT INTO HOW THE NORTH ATLANTIC ECONOMY ACHIEVED DECREASING INEQUALITY BETWEEN COUNTRIES IN THE LAST FIVE DECADES THEY ALSO GIVE INSIGHT INTO THE GREAT MIGRATION OF EUROPEANS FROM THE LAND SCARCE OLD WORLD TO THE LAND ABUNDANT NEW WORLD IN THE LATE 19TH AND EARLY 20TH CENTURY ACCOMPANIED BY THE PREDICTED MOVEMENTS IN LAND RENTAL WAGE RATIOS HOWEVER PRODUCTIVITY DIFFERENCES APPEAR TO BE AN IMPORTANT FACET OF MANY GLOBALIZATION INEQUALITY AND DEVELOPMENT EPISODES IN THE OLD GLOBALIZATION ERA THEY SEEM TO BE CRUCIAL TO UNDERSTAND THE LACK OF CONVERGENCE BETWEEN NORTH ATLANTIC ECONOMIES THE GREAT DIVERGENCE BETWEEN RICH AND POOR COUNTRIES IN THAT SAME ERA AND THE BIAS OF CAPITAL FLOWS TOWARDS RICH COUNTRIES IN THE NEW GLOBALIZATION ERA PRODUCTIVITY DIFFERENCES ARE IMPORTANT TO CAPTURE THE VERY DIFFERENT PERFORMANCE OF POOR COUNTRY REGIONS IN RECENT DECADES THE FLOW OF ALL FACTORS OF PRODUCTION TOWARDS THE RICH COUNTRIES THE LOW RETURNS TO PHYSICAL AND HUMAN CAPITAL IN MANY POOR COUNTRIES AND THE PERVERSE BEHAVIOR OF WITHIN COUNTRY INEQUALITY IN REACTION TO TRADE AND CAPITAL FLOWS

ABSTRACT THIS PAPER STUDIES THE WELFARE IMPLICATIONS OF TRADE OPENING IN A WORLD IN WHICH TRADE RAISES AGGREGATE INCOME BUT ALSO INCREASES INCOME INEQUALITY AND IN WHICH REDISTRIBUTION NEEDS TO OCCUR VIA A DISTORTIONARY INCOME TAX TRANSFER SYSTEM WE PROVIDE TOOLS TO CHARACTERIZE AND QUANTIFY THE EFFECTS OF TRADE OPENING ON THE DISTRIBUTION OF DISPOSABLE INCOME AFTER REDISTRIBUTION WE PROPOSE TWO ADJUSTMENTS TO STANDARD MEASURES OF THE WELFARE GAINS FROM TRADE A WELFARIST CORRECTION INSPIRED BY THE ATKINSON 1970 INDEX OF INEQUALITY AND A COSTLY REDISTRIBUTION CORRECTION CAPTURING THE EFFICIENCY COSTS ASSOCIATED WITH THE BEHAVIORAL RESPONSES OF AGENTS TO TRADE INDUCED SHIFTS ACROSS MARGINAL TAX RATES WE CALIBRATE OUR MODEL TO THE UNITED STATES OVER THE PERIOD 1979 2007 USING DATA ON THE DISTRIBUTION OF ADJUSTED GROSS INCOME IN PUBLIC SAMPLES OF IRS TAX RETURNS AS WELL AS CBO INFORMATION ON THE TAX LIABILITIES AND TRANSFERS RECEIVED BY AGENTS AT DIFFERENT PERCENTILES OF THE U S INCOME DISTRIBUTION OUR QUANTITATIVE RESULTS SUGGEST THAT BOTH CORRECTIONS ARE NONNEGLECTIBLE TRADE INDUCED INCREASES IN INEQUALITY OF DISPOSABLE INCOME ERODE ABOUT 20 OF THE GAINS FROM TRADE WHILE THE GAINS FROM TRADE WOULD BE ABOUT 15 LARGER IF REDISTRIBUTION WAS CARRIED OUT VIA NON DISTORTIONARY MEANS

WE ARE USED TO THINKING ABOUT INEQUALITY WITHIN COUNTRIES ABOUT RICH AMERICANS VERSUS POOR AMERICANS FOR INSTANCE BUT WHAT ABOUT INEQUALITY BETWEEN ALL CITIZENS OF THE WORLD WORLDS APART ADDRESSES JUST HOW TO MEASURE GLOBAL INEQUALITY AMONG INDIVIDUALS AND SHOWS THAT INEQUALITY IS SHAPED BY COMPLEX FORCES OFTEN WORKING IN DIFFERENT DIRECTIONS BRANKO MILANOVIC A TOP WORLD BANK ECONOMIST ANALYZES INCOME DISTRIBUTION WORLDWIDE USING FOR THE FIRST TIME HOUSEHOLD SURVEY DATA FROM MORE THAN 100 COUNTRIES HE EVENHANDEDLY EXPLAINS THE MAIN APPROACHES TO THE PROBLEM OFFERS A MORE ACCURATE WAY OF MEASURING INEQUALITY AMONG INDIVIDUALS AND DISCUSSES THE RELEVANT POLICIES OF FIRST WORLD COUNTRIES AND NONGOVERNMENTAL ORGANIZATIONS INEQUALITY HAS INCREASED BETWEEN NATIONS OVER THE LAST HALF CENTURY RICHER COUNTRIES HAVE GENERALLY GROWN FASTER THAN POORER COUNTRIES AND YET THE TWO MOST POPULOUS NATIONS CHINA AND INDIA HAVE ALSO GROWN FAST BUT OVER THE PAST TWO DECADES INEQUALITY WITHIN COUNTRIES
